NOTICE IS HEREBY GIVEN that the Annual General Meeting of AsiaPhos Limited (the "Company") will be held at PARKROYAL on Beach Road, Ballroom 3, 7500 Beach Road, Singapore 199591, on Wednesday, 30 April 2014 at 10.00 a.m. for the following purposes:
