While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

Tan Sri Cheng Heng Jem ("Tan Sri") is deemed to be interested in 26,903,000 ordinary shares comprising 18,320,000 ordinary shares deemed held by Lion Corporation Berhad ("LCB") and 8,450,000 ordinary shares held by Lion Enterprise (Kuala Lumpur) Sdn Bhd, 100,000 ordinary shares held by Lion AMB Resources Berhad and 33,000 ordinary shares held by Lion Industries Corporation Berhad.

LCB is deemed to be interested in 18,320,000 ordinary shares comprising 18,320,000 ordinary shares deemed held by ACB Resources Berhad ("ACB").

ACB is deemed to be interested in 18,320,000 ordinary shares comprising 5,583,000 ordinary shares deemed held by Akurjaya Sdn Bhd ("Akurjaya"), 9,462,000 ordinary shares deemed held by Angkasa Marketing (Singapore) Pte Ltd ("Angkasa Marketing") and 3,275,000 ordinary shares held by Umatrac Enterprises Sdn Bhd.
