Please elaborate on what caused the "inadvertent omission".

Company's response:

The inadvertent omission in question was due to human error and oversight in the preparation and review of the Notice of AGM and Proxy Form.

2. How will the Board prevent similar incidents in future?

Company's response:

The Board recognises the oversight in the preparation of the Notice of AGM and Proxy Form. To avoid future recurrence, the Board and the management of the Company have already implemented an additional checklist specifically for future notices of annual general meetings (and accompanying proxy forms). The Board will ensure that this checklist, together with existing checklists, are reviewed by the corporate secretarial service provider and the Continuing Sponsor of the Company, prior to finalising the said notices (and accompanying proxy forms).
