

## FAR EAST ORCHARD LIMITED SCRIP DIVIDEND SCHEME ISSUE PRICE OF NEW SHARES

Unless defined below, capitalized terms used in this Announcement have the same meanings as in the Company's announcement dated 24 April 2018 (SGXNET Announcement No. SG180424DVOPTG5A)

- 1. On 24 April 2018, the Company announced the application of its Scrip Dividend Scheme (the "**Scheme**") to the FY2017 Dividend and the Books Closure Date for determining Shareholders' entitlements to the FY2017 Dividend.
- 2. Further to the above, the Company wishes to announce that for the purposes of the application of the Scheme to the FY2017 Dividend, the price at which each New Share is to be issued ("Issue Price") credited as fully paid, to Shareholders who have elected to participate in the Scheme, in lieu of the cash amount of the FY2017 Dividend, is \$\$1.438 for each New Share, the average of the volume weighted average prices of a Share on the SGX-ST for each of the three market days during the period commencing on the day on which the Shares were first quoted ex-dividend on the SGX-ST after the announcement of the FY2017 Dividend and ending on 16 May 2018 (the Books Closure Date for the FY2017 Dividend).
- 3. Election Notices for the scrip elective with respect to the FY2017 Dividend will be despatched to eligible Shareholders on or about **25 May 2018**.
- 4. The FY2017 Dividend will be paid on or about **4 July 2018**. Shareholders not participating in the Scheme will receive the FY2017 Dividend in cash.
