Conversion and cancellation of S\$78,000,000 in aggregate principal amount of S\$175,000,000 2.5 per cent. Convertible Bonds due 12 September 2017, resulting in an issue of an aggregate of 54,679,281 new units in CCT. The total number of units in CCT in issue has increased from 3,006,284,332 to 3,060,963,613. As a result of such increase, the direct interest of SBR Private Limited and deemed interest of CapitaLand (Office) Investments Pte Ltd in units in CCT has decreased from 21.30% to 20.92%.
