MM2 ASIA TO CO-PRODUCE FIRST US FILM "GOOD MATCH" WITH BOULDERLIGHT PICTURES

"Good Match" will be mm2 Asia's first film investment in the US market

SINGAPORE, 17 MAY 2016 – mm2 Asia Ltd. ("mm2 Asia" "mm2 全亚影视娱乐有限公司" and together with its subsidiaries, the "Group"), today announced that its wholly owned subsidiary, mm2 Entertainment Pte Ltd ("mm2"), has signed a film co-production term sheet agreement with BoulderLight Pictures, a US-based production and international sales company behind notable productions like "Dementia", "Contracted" and "Uncaged".

mm2 Asia and BoulderLight Pictures will co-produce a film called "Good Match", a contemporary thriller about Harris, a good-looking bachelor who meets a seemingly perfect match on a social dating app. However, things take a dark turn when her behaviour starts to become erratic.

"Good Match" is *written by* rising genre screenwriter David Chirchirillo, whose previous previous credits include SXSW Midnight Award winner "Cheap Thrills" and Magnolia's "ABC's of Death 2". Recently, Chirchirillo's script "Eli" was selected for the Black List 2015, which recognises the year's most-liked unproduced screenplays as voted on by leading Hollywood film executives. Previous Black List screenplays include "Slumdog Millionaire", "The King's Speech" and "Argo".

"Good Match will be our first US film co-production and we're excited to take this significant step into the US market," said Mr Melvin Ang, CEO of mm2 Asia Ltd.

"This co-production with the young and innovative team at BoulderLight Pictures will help mm2 understand the US film entertainment market better and reaffirms our goal to produce quality international films."

"We are very excited to be partnering with MM2 on this exciting, highly relevant project," said J.D. Lifshitz, Founding Partner of BoulderLight Pictures.

Originally from New York, J.D. Lifshitz and Raphael Margules have been interested in film since before they first met in Hebrew School. Shortly after moving to LA, the two landed positions for acclaimed filmmakers Adam Wingard (You're Next) and David Tedeschi (George Harrison: Living in the Material World), respectively. Within a few months of their arrival, they were able to raise enough capital to upstart BoulderLight. Their first film, Contracted, went on to be a major VOD hit for IFC Films, garnering a limited theatrical release, before going on to be the most streamed film on Netflix. A sequel, Contracted: Phase II was pre-sold to IFC and was released in Fall 2015.

Since then, BoulderLight has produced Uncaged, a new take on the werewolf mythology (sold to RLJ/Image Entertainment), and Dementia, an innovative horror/thriller with an all-star genre cast, recently picked up by IFC, and set for release on December 4th, 2015.

At the 2014 Cannes Marche du Film, BoulderLight launched its international sales arm, with a strong focus on bringing exciting and fresh genre content to foreign markets. BoulderLight attends all the major markets, including: Cannes, EFM, AFM, and Sundance. They have garnered relationships with some of the biggest independent distributors across the world.
