On 18 October 2023, pursuant to an internal restructuring, Siriwanan Co., Ltd. ("Siriwanan") which is wholly-owned by Siriwana Co., Ltd. ("Siriwana"), entered into a conditional sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") to acquire from Golden Capital (the "Transaction") 700,000,000 ordinary shares of Thai Beverage Public Company Limited ("THBEV" and its shares, the "THBEV Shares"), representing a direct interest of approximately 2.7861% in the issued share capital of THBEV (the "Sale Shares"). Siriwana holds a direct interest in 11,368,060,000 THBEV Shares representing approximately 45.2465% in THBEV Shares, and through Siriwanan's 2,200,000,000 THBEV Shares, an indirect interest of approximately 8.7563% in THBEV Shares.

Completion of the Transaction has not taken place and is subject to the satisfaction of certain conditions as specified under the SPA. Siriwanan therefore has a deemed interest in the Sale Shares. Following the completion of the Transaction, Siriwanan's interest in THBEV Shares will increase from 8.7563% to approximately 11.5424%, and Siriwana's interest in THBEV Shares, direct and indirect through Siriwanan, will increase from 54.0028% to approximately 56.7889%.

Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi, jointly hold a 51% direct interest in Siriwana. The remaining 49% in the shares of Siriwana is held directly by Shiny Treasure Holdings Limited ("Shiny Treasure"), which is in turn wholly-owned by Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi.


THBEV holds a 100% direct interest in International Beverage Holdings Limited, which in turns holds a 100% direct interest in InterBev Investment Limited ("IBIL"). IBIL has a direct interest of 28.7832% in the shares of the Company.

Shiny Treasure is deemed to be interested in all the THBEV Shares in which Siriwana has an interest, and in all the shares in the Company in which IBIL has an interest.

Each of Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi is therefore deemed to be interested in all the shares in the Company in which IBIL has an interest.

TCC Assets Limited ("TCCA") has a direct interest of 58.1028% in the shares of the Company. Each of Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi owns 50% of the issued share capital of TCCA, and is therefore deemed to be interested in all of the shares in the Company in which TCCA has an interest.
