- 1. **Background**. Informatics Education Ltd. (the "Company") refers to:
 - (a) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
 - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order"), and as amended by COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) (Amendment No. 2) Order 2020, which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies; and
 - (c) the joint statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation of 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020 and 1 October 2020) which provides additional guidance on the conduct of general meetings during the period from 27 March 2020 to 30 June 2021.
- 2. Date, time and conduct of Annual General Meeting ("AGM") and Extraordinary General Meeting ("EGM"). Pursuant to the Order, the Company has the option to hold a virtual meeting, even where the Company is permitted under safe distancing measures to hold a physical meeting. Due to the current COVID-19 situation and the Company's efforts to minimise physical interactions and COVID-19 transmission risk to a minimum, the Company is pleased to announce that its AGM and EGM will be convened and held by way of electronic means, on Thursday, 26 November 2020 at 2.00 p.m. and 2.30 p.m. (or immediately following the conclusion or adjournment of AGM) respectively.
- 3. Annual Report 2020, Circular to Shareholders, Notices of AGM and EGM and Proxy Forms. The Annual Report 2020, Circular to Shareholders, Notices of AGM and EGM and Proxy Forms have been published on the Company's website at http://www.informaticseducation.com/investor-media-centre/ and on the SGX website at https://www.sgx.com/securities/company-announcements. Printed copies of these documents will NOT be despatched to shareholders.
- 4. **No personal attendance at AGM and EGM**. The Company does not allow real-time remote electronic voting through an electronic voting system to take place at the AGM and EGM, a member (whether individual or corporate) must appoint the Chairman of the Meeting as his/her/its proxy to vote on his/her/its behalf at the AGM and EGM if such member wishes to exercise his/her/its voting rights at the AGM and EGM.
- 5. **Alternative arrangements for participation at the AGM and EGM**. Shareholders may participate at the AGM and EGM by:
 - (a) observing and / or listening to the AGM and EGM proceedings via live audio-visual webcast or audio-only means;
 - (b) submitting questions in advance of the AGM and EGM; and
 - (c) appointing the Chairman of the Meeting as proxy to vote on their behalf at the AGM and EGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGM and EGM are set out in the Appendix to this announcement.

- 6. **Persons who hold shares through relevant intermediaries**. Persons who hold the Company's shares through relevant intermediaries (as defined in section 181 of the Companies Act, Chapter 50), including CPF and SRS investors, and who wish to participate in the AGM and EGM by:
 - (a) observing and / or listening to the AGM and EGM proceedings via live audio-visual webcast or audio-only means;
 - (b) submitting questions in advance of the AGM and EGM; and / or
 - (c) appointing the Chairman of the Meeting as proxy to vote on their behalf at the AGM and EGM,

should contact the relevant intermediary (which would include, in the case of CPF and SRS investors, their respective CPF Agent Banks and SRS Operators) through which they hold such shares as soon as possible in order for the necessary arrangements to be made for their participation in the AGM and EGM.

- 7. **Further information**. Details of the steps for pre-registration, pre-submission of questions and voting at the AGM and EGM are set out in the Appendix to this announcement.
- 8. Important reminder. Due to the constantly evolving COVID-19 situation in Singapore, we may be required to change our arrangements for the AGM and EGM at short notice.
