1. MLHS Holdings Pte Ltd ("MLHS") holds more than 50 per cent. of the issued shares in Aspial Corporation Limited ("Aspial") and is deemed to have an interest in any Maxi-Cash Shares held by Aspial.
2. Koh Wee Seng holds a direct interest of 18.70 per cent. of shares in Aspial. In addition, Koh Wee Seng also holds more than 20 per cent. of the issued shares in MLHS. Koh Wee Seng is accordingly deemed to have an interest in any Maxi-Cash Shares in which MLHS has an interest.
3. Further, pursuant to the Securities and Futures Act, Koh Wee Seng is deemed to have an interest in any Maxi-Cash Shares held by his spouse.
