Reason for replacement of notification: The nature of change in interest of Mr. Liew Jat Yuen, Richard was mistakenly treated as "Lapse of provisional allotment of 143,750 nil-paid rights" in the previous announcement released by the Company on 4 July 2016.

The nature of change in interest of Director should be " Acceptance of 143,750 nil-paid rights and 168,750 excess rights pursuant to the Company's Right Issue", resulting the number of shares held by Mr. Liew Jat Yuen, Richard increased from 287,500 shares (0.09%) to 600,000 shares (0.13%).

The percentage of shareholding immediately before the Rights Issue is calculated based on the total number of issued shares in the Company of 316,735,383. The percentage of shareholding immediately after the Rights Issue is calculated based on the total number of issues shares in the Company of 475,102,931 shares representing the enlarged share capital in the Company upon the allotment and issuance of 158,367,548 Rights Shares.
