Logistics Holdings wins S\$13.8 million contract from JTC

Corporation for addition and alteration works on

conserved buildings at Seletar Aerospace Park

Contract involves the addition and alteration ("A&A") of six conserved

buildings and infrastructure works at Park Lane, The Oval and Hyde Park

Gate at Seletar Aerospace Park

Current order book stands at \$\$278.9 million

Singapore, 17 June 2015 – Logistics Holdings Limited (實特控股有限公司) ("Logistics Holdings", and

together with its subsidiaries, the "Group") a construction group principally engaged in building

construction works as well as supply and installation of furniture/interior fitting-out works, has

secured a S\$13.8 million contract through its wholly-owned subsidiary, Logistics Construction Pte Ltd,

from the JTC Corporation ("JTC").

The contract involves addition and alteration ("A&A") works to six existing conserved buildings and

infrastructure works at Park Lane, The Oval and Hyde Park Gate at Seletar Aerospace Park. The

construction work is scheduled to commence on 22 June 2015 and is expected to complete by 21

March 2016.

The Group has done A&A projects for JTC in the past, most notably the A&A works to JTC Summit at

Jurong East. Mr Phua Lam Soon, PBM (潘南舜), Chief Executive Officer of Logistics Holdings,

commented, "The securing of yet another A&A project from JTC is a testimony of our experience

and capability. It shows the confidence our clients have in our ability to complete public sector

projects."

The Urban Redevelopment Authority (URA) and JTC have slated several bungalows along Hyde Park Gate and The Oval for conservational redevelopment into a series of restaurants, spas and other leisure activity areas, with the aim of bringing back the vibrancy and charm back to the Seletar area. Such conservation work can contribute to the continued sense of history and identity in Seletar, a former British's Royal Air Force (RAF) station and an army camp.

Mr Phua added, "We are happy to be involved in such conservation project work. It is very meaningful to play a part to preserve an important era in Singapore's military history."

The latest contract win boosted the Group's order book to \$\$278.9 million, with projects expected to last until the financial year ending 30 June 2019 ("**FY2019**").
