FINANCIAL UPDATE FOR THE SECOND QUARTER ENDED 30 JUNE 2018

The Board of Directors of Global Palm Resources Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) wishes to announce that, following a preliminary review of the unaudited financial statements for the quarter ended 30 June 2018 (“**2Q2018**”), the Group is expected to report a net profit after tax which will be substantially lower than that of the preceding quarter ended 30 June 2017.

The lower net profit after tax is primarily attributable to the decrease in the sales volume of crude palm oil and palm kernel.

The Group is still in the process of finalizing its unaudited financial results for 2Q2018. Further details of the performance of the Group will be disclosed in its unaudited financial statements announcement for 2Q2018, which is expected to be released on or before 14 August 2018.
