The Board of Directors of mDR Limited (the “**Company**” and together with its subsidiaries the “**Group**”) wishes to announce that pursuant to Rule 704(17)(b) of the Mainboard Rules of the Listing Manual of the Singapore Exchange Securities Trading Limited, the Group has acquired quoted securities for a total value of approximately S\$3,547,212 for the period 16 November 2024 to 28 November 2024. This is equivalent to 3.7% of the latest audited net tangible assets of the Group.
