ISSUE PRICE OF UNITS PURSUANT TO THE ESR-REIT DISTRIBUTION REINVESTMENT PLAN

ESR Funds Management (S) Limited, as the manager of ESR-REIT (the “**Manager**”), wishes to announce that the issue price of the units in ESR-REIT pursuant to the application of the ESR-REIT Distribution Reinvestment Plan to ESR-REIT’s distribution for the period from 1 April 2020 to 30 June 2020 (“**DRP Units**”) is S\$0.4018 per DRP Unit.

The issue price of S\$0.4018 per DRP Unit represents a discount of 2.0% to the volume-weighted average traded price per ESR-REIT unit for all trades done on the Singapore Exchange Securities Trading Limited from 23 July 2020 to 24 July 2020 (both dates inclusive).

ESR-REIT invests in quality income-producing industrial properties and as at 30 June 2020 holds interest in a diversified portfolio of 57 properties located across Singapore, with a total gross floor area of approximately 15.1 million square feet and an aggregate property value of S\$3.1 billion¹. The properties are in the following business sectors: Business Park, High-Specs Industrial, Logistics/Warehouse and General Industrial, and are located close to major transportation hubs and key industrial zones island-wide.
