Ms Ho Yow Ping (He YouPing) holds 21.70% interest in the issued share capital of Suki Sushi and is also the wife of Mr Lee Boon Leng who holds 73.75% interest in the issued share capital of Suki Sushi. Accordingly, Ms Ho is deemed to have an interest in the shares owned by Suki Sushi by virtue of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore.
