SINGAPORE MEDICAL GROUP (SMG) AND CIPUTRA GROUP, INDONESIA SIGN MEMORANDUM OF UNDERSTANDING TO ESTABLISH THE CIPUTRA SMG EYE CLINIC IN JAKARTA

Singapore, **14 January 2014** – A non-binding Memorandum of Understanding (MOU) has been signed between Singapore Medical Group (SMG) and Ciputra Group, Indonesia to establish the Ciputra SMG Eye Clinic in Ciputra Medical Centre, located in the Mall of Ciputra World 1, Lotte Shopping Avenue, Jakarta, Indonesia on 8 January 2014 (the "Joint Venture").

Ciputra Group is one of the largest and most diversified property developers in Indonesia.

The MOU commits the two organisations to cooperate and establish the joint healthcare venture, the Ciputra SMG Eye Clinic that focuses on serving patients requiring vision correction and treatment through LASIK surgery and cataract surgery.

The MOU is valid for six months and shall expire on 8 July 2014, or until the signing of a joint venture agreement for the establishment and operation of a joint venture company (the "JV Company"), whichever is the earlier.

Commenting on the significance of the MOU, Dr Beng Teck Liang, Chief Executive Officer of SMG said, "Indonesia is a very important medical tourism market for SMG and we are delighted to be able to continue extending Singapore's high standards and quality healthcare outside our shores. We are extremely excited to work with Ciputra Group to provide patients in Indonesia with FDA-approved laser vision correction technologies as well as safe and reliable cataract surgery to regain their vision. We are committed to work with Ciputra Group to deliver patient centered medical care and experience to every individual."

SMG operates one of the largest and most established private LASIK and cataract surgery eye centres in Singapore, having treated more than 77,000 eyes since 2005 and been awarded the highest volume VISX (1) treatment site in the world by Advanced Medical Optics (AMO) for 2 consecutive years in 2007 and 2008.

Mr. Cakra Ciputra, President Director of Ciputra Group added, "There is an increasing number of patients in Indonesia seeking premium healthcare services and treatments in the area of vision care. We would like to take on the role of educating Indonesians on vision care and vision restoration. We are very proud to be partnering with SMG who is highly experienced in this medical specialty. We are dedicated to deliver high quality medical services with internationally recognised standards of care, handled by reliable and well-trained doctors."

(1) VISX – This is a device that includes a refractive excimer laser system that uses invisible ultraviolet (UV) light pulses to remove precise amounts of corneal tissue from the eye according to the treatment plan; an eyetracker that detects the position of the eye and aligns the laser pulse with the cornea; a diagnostic wavefront sensor for the automated measurement, analysis, and recording of refractive errors of the eye; and an automated iris registration (IRTM) system to rotate the treatment to align with the rotation of the eye under the laser.
