Sanli Environmental Clinches Contracts Worth S\$35 Million in Singapore

- New contracts boost the Group's order book to approximately \$\$335.9 million
- New customers acquired include Tuas Power, Gardens by the Bay and URA

SINGAPORE, 22 January 2024 – SGX-Catalist listed Sanli Environmental Limited ("Sanli", "the Company", "三立环境有限公司" and together with its subsidiaries, the "Group"), one of Singapore's leading environmental engineering companies, is delighted to share the exciting news that its wholly-owned subsidiary, Sanli M&E Engineering Pte. Ltd., has recently clinched contracts in Singapore, with a cumulative worth of S\$35 million (the "Contracts").

The Contracts encompass a diverse range of projects and maintenance services, including servicing and maintenance of multiple water plants for PUB, the overhaul of 6.6KV Induction Motors for Tuas Power, the comprehensive maintenance of the Flower Dome External Shading System at Gardens by the Bay, and replacement of the Sump Pump System and relocation of Control Panels at a facility in Marina Bay for URA.

This achievement not only underscores the Group's commitment to excellence but also signifies the expansion of its clientele with the addition of esteemed organisations such as Tuas Power, Gardens by the Bay, and the Urban Redevelopment Authority ("URA"). These collaborations

contribute significantly to the Group's current order book, which now stands at approximately \$\$335.9 million. Barring any unforeseen circumstances, majority of the order book is expected to be fulfilled over the next 3 years.

While the financial impact on earnings per share or net tangible assets per share for the financial year ending 31 March 2024 is expected to be minimal, the Group anticipates these contracts to positively contribute to its financial performance in the subsequent financial year ending 31 March 2025.

None of the Directors and controlling shareholders of the Company, as well as their respective associates, has any interest, direct or indirect, in new contracts, save for their shareholdings in the Company (if any).

Mr Sim Hock Heng, Chief Executive Officer and Executive Director of Sanli commented: "We are delighted for the acquisition of new customers like Tuas Power, Gardens by the Bay, and URA, which is a major achievement for our operations and maintenance business as it will contribute to a larger and more diverse customer base for the Group. We will continue to build up our order book to drive our growth, by leveraging our strong environmental engineering expertise and track record. We have also moved to our new premises at 22 Chin Bee Drive, which houses our corporate office, workshop, and dormitory in one location and allows us to enhance our efficiencies while lowering our long-term operating costs."
