On 3 July 2023, HMC and OUEH Investments Pte. Ltd. ("Offeror"), a wholly-owned subsidiary of OUE Healthcare Limited ("OUEH"), announced a proposed voluntary delisting of and exit offer for HMC ("Exit Offer"). Pursuant to the Exit Offer, the Offeror received valid acceptances in respect of an aggregate of 1,189,993,563 shares in HMC ("Shares") as at 26 October 2023, being the date of the close of the Exit Offer.

OUEH, Golden Concord Asia Limited ("GCAL"), Fortune Crane Limited ("FCL"), Lippo ASM Asia Property Limited ("LAAPL"), HKC Property Investment Holdings Limited ("HKC Property"), Hongkong Chinese Limited ("HCL") and Hennessy Holdings Limited ("HHL") have each become a substantial shareholder of HMC because they each have a deemed interest in Shares held by the Offeror, as described in paragraph 9 below.
