1. INTRODUCTION

Keppel Pegasus Pte. Ltd. (the "<u>Offeror</u>"), a wholly-owned subsidiary of Keppel Corporation Limited ("<u>KCL</u>"), refers to the following announcements:

- (a) the joint announcement issued by the Offeror and Singapore Press Holdings Limited ("SPH") on 2 August 2021 (the "Joint Announcement") in relation to the proposed acquisition by the Offeror of all the issued and paid-up ordinary shares (excluding treasury shares) in the capital of SPH by way of a scheme of arrangement under Section 210 of the Companies Act (Chapter 50 of Singapore); and
- (b) the announcement dated 6 August 2021 issued by Keppel REIT Management Limited ("KRML"), as manager of Keppel REIT in connection with the payment of the base fee component of its management fee for the period from 1 April 2021 to 30 June 2021 by way of the issue of 8,863,381 units in Keppel REIT (the "K-REIT Units") at a price of S\$1.1696 per K-REIT Unit.

All capitalised terms used and not defined herein shall have the same meanings given to them in the Joint Announcement, unless otherwise expressly stated or the context otherwise requires.

2. **DEALING**
