ANNOUNCEMENT

S\$650,000,000 1.85 PER CENT. CONVERTIBLE BONDS DUE 2020 PAYMENT OF INTEREST

CapitaLand Limited ("**CapitaLand**") refers to the S\$650,000,000 principal amount of 1.85 per cent. convertible bonds due 2020 issued by CapitaLand on 19 June 2013 (the "**Bonds**"). As at the date of this Announcement, the aggregate outstanding principal amount of the Bonds is S\$650,000,000.

CapitaLand wishes to announce that the upcoming interest payment on the Bonds will be made on 19 June 2018.

Under the terms and conditions of the Bonds, interest at the rate of 1.85 per cent. per annum is payable semi-annually in arrear on 19 June and 19 December in each year (each an "Interest Payment Date"), commencing 19 December 2013. Interest will be paid to the bondholder whose name is shown on the Register of Bondholder at the close of business on the 5th business day before the due date for the payment of interest. Each Bond will cease to bear interest, amongst other things, from and including the Interest Payment Date last preceding its conversion date.

Payment will be made by transfer to the registered account of the bondholder or by Singapore dollar cheque drawn on a bank in Singapore mailed to the registered address of the bondholder, if the bondholder does not have a registered account.

Where payment is to be made by transfer to a registered account, payment instructions will be initiated on 19 June 2018.

Where payment is to be made by cheque, the cheque will be mailed on 19 June 2018 at the risk of the bondholder and, if mailed at the request of the bondholder other than by ordinary mail, at the expense of the bondholder.

Bondholders shall not be entitled to any interest or other payment for any delay in their receipt of the interest payment.
