The following entities (collectively, "Relevant Entities") acquired an aggregate of 31,399,641 new Units in the Preferential Offering, as follows:

- (i) KL acquired an aggregate of 30,318,449 new Units.
- (ii) Fullerton acquired 339,173 new Units.
