Temasek is filing this notification form to report a change in the percentage level of its deemed interest in Units from 17.86% to 18.08%, as a result of the issuance of 148,413,063 new Units on 18 December 2024 pursuant to the Preferential Offering (as defined in the Listed Issuer's announcements on 19 November 2024, 12 and 18 December 2024). The following entities (collectively, "Relevant Entities") acquired an aggregate of 31,399,641 new Units in the Preferential Offering, as follows: (i) KL acquired an aggregate of 30,318,449 new Units.
