



ALLOTMENT AND ISSUANCE OF NEW SHARES PURSUANT TO THE VESTING OF SHARE AWARDS GRANTED ON 15 OCTOBER 2021 UNDER THE TALKMED GROUP PERFORMANCE SHARE PLAN (“PSP”)

The Board of Directors (the “**Board**” or “**Directors**”) of TalkMed Group Limited (the “**Company**”, together with its subsidiaries, collectively, the “**Group**”) refers to the Company’s announcement dated 15 October 2021 in relation to the grant of share awards pursuant to the PSP (“**Share Awards**”).

In relation to the Share Awards, the Board is pleased to announce that the Company has allotted and issued 499,999 new ordinary shares on 16 October 2023 pursuant to the vesting of the Share Awards.
