PLTIP - In order to satisfy anticipated releases of shares to participants following the vesting of awards under the PLTIP, new ordinary shares are from time to time issued by the Company and allotted to Sanne Fiduciary Services Limited, thereby increasing the Company's issued ordinary share capital. These shares are held by the Prudential Employee Share Trust on behalf of the participants of the PLTIP and released to them when their awards vest (as appropriate).

Renewed ISSOSNE and Agency LTIP - In order to satisfy anticipated exercises of options under the Renewed ISSOSNE, and the anticipated releases of shares to participants following the vesting of awards under the Agency LTIP, new ordinary shares are from time to time issued by the Company and allotted to Asian Agency SPV Limited, thereby increasing the Company's issued ordinary share capital. These shares are held by the Prudential Agent Share Trust on behalf of the participants of the Renewed ISSOSNE and the Agency LTIP, and released to them when they exercise their option or when their awards vest (as appropriate).
