PAYMENT OF BASE MANAGEMENT FEE AND PERFORMANCE FEE BY WAY OF ISSUE OF NEW STAPLED SECURITIES IN FAR EAST HOSPITALITY TRUST

FEO Hospitality Asset Management Pte. Ltd. (the “REIT Manager”), as manager of Far East Hospitality Real Estate Investment Trust (“Far East H-REIT”), and FEO Hospitality Trust Management Pte. Ltd. (the “Trustee-Manager”), as trustee-manager of Far East Hospitality Business Trust (“Far East H-BT”), wish to announce that 3,379,852 stapled securities in Far East Hospitality Trust (“Far East H-Trust”), each stapled security comprising one unit in Far East H-REIT and one unit in Far East H-BT, have been credited on 29 July 2015 to the accounts of the REIT Manager at an issue price of approximately S\$0.7829 per Far East H-Trust stapled security.

The issue price per stapled security was based on the volume weighted average price for a stapled security for all trades on the Singapore Exchange Securities Trading Limited for the last ten (10) business days of the relevant period in which the Management Fee accrues i.e. 17 June 2015 to 30 June 2015.

For the financial year ending 31 December 2015, FEO Hospitality Asset Management Pte. Ltd., as manager of Far East H-REIT, has elected to receive 90% of its management fee in stapled securities and the balance in cash.

Far East H-BT is dormant and the value of the Far East H-BT Trust Property is less than S\$ 50 million, and that, as a result, no Trustee-Manager fees are payable to the Trustee-Manager of Far East H-BT.

With the above-mentioned issue of new stapled securities, the REIT Manager holds an aggregate of 28,914,621 i.e. 1.62% of Far East H-Trust stapled securities and the total number of Far East H-Trust stapled securities in issue is 1,784,583,621 as at the date of this announcement.
