Reference is made to the exit offer letter dated 5 September 2023 in relation to the conditional exit offer (the "Exit Offer") by Oversea-Chinese Banking Corporation Limited, for and on behalf of OUEH Investments Pte. Ltd. (the "Offeror") to acquire all the issued and paid-up ordinary shares (the "Shares") in the capital of Healthway Medical Corporation Limited (the "Company") (excluding treasury shares) other than those already owned, controlled or agreed to be acquired by the Offeror and the parties acting in concert with it as at the date of the Exit Offer (the "Offer Shares"), at \$\$0.048 per Offer Share. The Exit Offer had become and was declared unconditional in all respects on 28 September 2023 (the "Exit Offer Unconditional Date").

The Offeror had received valid acceptances in respect of an aggregate of 1,189,993,563 Offer Shares pursuant to the Exit Offer, during the period the Exit Offer was open for acceptances from 5 September 2023 to 26 October 2023.

Since the Exit Offer Unconditional Date, settlement for the Exit Offer has been, and will be, made on a rolling basis in compliance with Rule 30 of the Singapore Code on Take-overs and Mergers ("Code").

As at the close of the Exit Offer at 5.30 p.m. (Singapore time) on 26 October 2023, the Offeror has (a) a direct interest in 1,150,816,406 Shares held in the Offeror's name (in respect of Shares in scrip form) or through the Offeror's CDP account (in respect of Shares which are deposited with CDP), for which acceptances have been settled by the Offeror pursuant to the Exit Offer; and (b) a deemed interest in 39,177,157 Shares, being the Shares which have been tendered in acceptance of the Exit Offer but for which acceptances have yet to be settled as at the close of the Exit Offer, but which will be settled in accordance with the timelines stipulated under the Code.

OUEH Investments Pte. Ltd. is a wholly-owned subsidiary of OUELH (Singapore) Pte. Ltd., which is in turn a wholly-owned subsidiary of OUELH (SEA) Pte. Ltd., which is in turn a wholly-owned subsidiary of OUE Healthcare Limited. Treasure International Holdings Pte. Ltd. holds approximately 70.36% of the issued share capital of OUE Healthcare Limited, and Treasure International Holdings Pte. Ltd. is in turn a wholly-owned subsidiary of OUE Limited.
