# UPDATE ON THE PROPOSED DISPOSAL OF ASSOCIATED COMPANY - COSMOS TECHNOLOGY INTERNATIONAL BERHAD

Capitalised terms used herein shall have the meanings ascribed to them in the Relevant Announcements (as defined below), unless otherwise stated or the context otherwise requires.

The Board of Directors (the "Board") of MSM International Limited (the "Company") refers to the Company's announcement dated 14 November 2024 and 29 November 2024 (the "Relevant Announcements") in relation to the proposed disposal of 21% of its shareholding interests, which is equivalent to 53,864,322 ordinary shares, in the capital of its associated company, Cosmos Technology International Berhad ("Cosmos") ("Sale Shares"), to the Purchasers for a cash consideration of RM21,244,088.60 ("Consideration") ("Proposed Disposal").

The Board wishes to announce that following the receipt of the payment from the Purchasers and execution of the transfer of Sale Shares by the designated brokers mutually agreed by both parties, the disposal of the Sale Sales to HPSP, Lew Jin Aun and Dang Yee Fong has been fully completed on 16 December 2024. The disposal of the Sale Shares has to date only been partially completed for Dato' Foong Wei Kuong based on the receipt of partial payment and corresponding share transfer executed while the disposal of shares to ISET is yet to commence. The details of the Consideration received and Sale Shares transferred to date is set out below:

Based on the terms of the Disposal SSA, the completion of the disposal of remaining Sale Shares to Dato' Foong Wei Kuong and ISET are to be completed on or before 13 February 2025, and the Company will announce further updates to shareholders accordingly.

Following the partial completion of the Proposed Disposal, the Company currently holds approximately 16.56% shareholding interests (42,483,400 ordinary shares) in Cosmos and Cosmos has ceased to be an associated company of the Group.
