APPLICATION FOR EXTENSION OF TIME IN RESPECT OF RULE 707(1) OF THE LISTING MANUAL TO HOLD THE COMPANY'S ANNUAL GENERAL MEETING FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2022 ("FY2022")

- 1. The Board of Directors (the "Board") of ASTI Holdings Limited (the "Company", and together with its subsidiaries, the "Group") wishes to announce that the Company has on 28 April 2023 applied to the Singapore Exchange Securities Trading Limited (the "SGX-ST") for an extension to 30 November 2023 to hold its annual general meeting ("AGM") for FY2022 pursuant to Rule 707(1) of the SGX-ST Listing Manual and the Notice of Compliance received on 27 April 2023 (the "NOC") directing it to, inter alia, convene its annual general meeting for the financial year ended 31 December 2022 by 31 July 2023 (the "Application").
- 2. The reasons for seeking the Application are as follows:
 - (a) As announced on 12 July 2022, Ernst & Young ("EY") is unable to provide an audit opinion for the financial statement for FY2021 in time for the AGM to be held by 29 July 2022 as the EY Valuation Team is still reviewing the draft valuation results of EoCell provided by Cushman and Wakefield VHS Pte Ltd. In the event that the EY Valuation Team is unable to give clearance, there will be a qualified opinion on the EoCell Valuation.
 - (b) In the Company's response to the SGX Query dated 13 February 2023, the Company has mentioned that the audit work by EY for the FY2021 accounts is ongoing and has also provided an indicative timeline (refer to Appendix) to convene the FY2021 AGM.
 - (c) The Company is currently working with EY and a newly appointed valuer to finalise the EoCell Valuation and complete the FY2021 accounts and is striving to hold the FY2021 AGM by 31 July 2023 as directed in the NOC. As the Company's auditors however can only begin their audit work for FY2022 accounts after the FY2021 accounts have been approved at the FY2021 AGM, more time is needed for auditors to finalise the FY2022 accounts.
- 3. Based on the foregoing, the Company has submitted the Application to the SGX-ST. The Company will announce the outcome of the Application in due course.
