Mr Cheo Seng Jin has assigned his voting rights in respect of the 20,912,000 shares to Unity Investment Inc. ("Unity"). With effect from 4 September 2023, the voting rights would be reduced by 2,000,000 shares to 18,912,000 shares.

Unity is wholly owned by Dr. T.C. Pierre (Cayman Island) Inc., which is wholly owned by SG Kleinwort Hambros Trust Company (Channel Islands) Limited as trustee of the TC Peter MD Settlement.

Ms Bianca Cheo Hui Hsin deemed interested as she is one of the beneficiaries of the TC Peter MD Settlement. The total quantum of interests in securities held by Ms Bianca Cheo Hui Hsin remains unchanged.
