

FAR EAST ORCHARD LIMITED SCRIP DIVIDEND SCHEME

APPLICATION OF THE SCHEME TO THE FY2021 DIVIDEND - DESPATCH OF ELECTION NOTICES

Unless defined below, capitalized terms used in this Announcement have the same meanings as used in the Company's announcements dated 18 April 2022 and 11 May 2022 (SGXNet Announcement No. SG220418DVOPMHAV).

The Company had previously announced the application of the Scheme to the FY2021 Dividend and the Record Date for determining Shareholders' entitlements to the FY2021 Dividend.

On the Record Date, the Company announced that the Issue Price at which each of the New Shares is to be issued, credited as fully paid, to eligible Shareholders who have elected to participate in the Scheme, in lieu of the cash amount of the FY2021 Dividend, is **\$\$1.070**.

Further to the above, the Company wishes to announce the following:

1. Despatch of Election Notices

Election Notices will be despatched today, 23 May 2022, to all persons registered as holders of Shares in the Register of Members of the Company or the Depository Register, as the case may be, as at 5.00 p.m. on 11 May 2022 (the Record Date for the FY2021 Dividend) to whom the Scheme has been made available (collectively, the "**Eligible Shareholders**").

2. Closing Date for Participation

Eligible Shareholders who wish to elect to participate in the Scheme must complete, sign and return their Election Notices to the Company c/o its share registrar, Boardroom Corporate & Advisory Services Pte. Ltd. ("**Share Registrar**"), or if they are CDP depositors, to CDP, as the case may be, at their respective addresses set out below, **by 5.00 p.m. on 8 June 2022**, Singapore time. Election Notices received after 5.00 p.m. on 8 June 2022, Singapore time, will not be effective and will not be processed.

Eligible Shareholders who wish to receive the FY2021 Dividend in cash need not take any action.

Eligible Shareholders who have not received their Notices of Election by 27 May 2022 should notify the Share Registrar or CDP, as the case may be, at the following addresses:
