The Board of Directors of Hi-P International Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) wishes to announce that the registered capital of its wholly-owned subsidiary, Hi-P (Suzhou) Precision Mold & Die Co., Ltd. (“**Subsidiary**”), has been increased by USD10 million from USD2.5 million to USD12.5 million. The said registered capital of the Subsidiary will be paid up in full in due course.

The Company continues to own 100% of the Subsidiary after such increase in registered capital.

The sum of USD10 million will be funded through the Group’s internal resources and is not expected to have any material impact on the Group’s earnings per share and net tangible assets per share for the financial year ending 31 December 2019.

None of the directors or substantial shareholders of the Company have any interest, direct or indirect (other than through their shareholdings in the Company), in the above transaction.
