The 73,430,837 ordinary shares in the capital of Fu Yu were sold by Mr Ching Heng Yang to the Purchaser on 18 January 2021 pursuant to a sale and purchase agreement entered into among the Vendors and the Purchaser on 13 January 2021 ("SPA").

Pursuant to the SPA, the consideration of S\$19,092,017.62 payable to Mr Ching Heng Yang is to be paid in two tranches: the first tranche of S\$15,707,655.08 was paid to Mr Ching Heng Yang on 18 January 2021, and the second tranche of S\$3,384,362.54 is to be paid to Mr Ching Heng Yang at a later date in accordance with the terms of the SPA.
