On 17 July 2024, pursuant to an internal restructuring, InterBev Investment Limited ("IBIL") entered into a conditional share swap agreement ("SSA") with TCC Assets Limited ("TCCAL") pursuant to which (a) TCCAL shall transfer or procure the transfer to IBIL and/or its nominees 601,627,606 ordinary shares (the "F&N Transfer Shares") in the capital of Fraser and Neave, Limited ("F&N") (which represents approximately 41.31% of the total number of issued shares of F&N (excluding treasury shares) such shares, the "F&N Shares"); and (b) IBIL shall transfer to TCCAL and/or its nominees 1,130,041,272 ordinary shares in the capital of Frasers Property Limited ("FPL") (which represents approximately 28.78% of the total number of issued shares of FPL (excluding treasury shares)) (the "Proposed Share Swap").

Completion of the Proposed Share Swap under the SSA took place on 20 September 2024. Following this, TCCAL's percentage interest in the F&N Shares has decreased from approximately 58.92% to approximately 17.61%.

F&N Shareholding percentages are based on a total of 1,456,444,679 shares in issue (excluding treasury shares).
