Ltd.

In connection with the above, the IL_D010_1/SGD, which was launched on 19 September 2024, under the SDAX CP Facility Programme, had matured on 22 October 2024.

Accordingly, the 50 Tokens under the IL_D010_1/SGD (with an aggregate principal amount of S\$500,000) that were issued to Mr Mak Lye Mun have been fully redeemed by the Company on 22 October 2024.

The Company had, under its SDAX CP Facility Programme, launched the eleventh series of its commercial papers with a tenor of 1 month (IL_D011_1/SGD Issue) represented by digital tokens ("Tokens") on 22 October 2024. The IL_D011_1/SGD Issue was issued at an interest rate of 4.00% per annum, and matures on 21 November 2024 from the issuance of IL_D011_1/SGD Tokens that are issued by the Company and listed on the SDAX Platform to accredited investors and institutional investors.

Mr Mak Lye Mun has subscribed for 70 Tokens with an aggregate principal amount of S\$700,000 under the IL_D011_1/SGD Issue. Ms Josandi Thor, spouse of Mr Mak Lye Mun, has subscribed for 100 Tokens with an aggregate principal amount of S\$1,000,000 under the IL_D011_1/SGD Issue. Accordingly, Mr Mak is deemed to be interested in the 100 Tokens held by Ms Thor.
