#### **1. INTRODUCTION**

United Overseas Bank Limited (“**UOB**”) refers to the proposed acquisition (the “**Acquisition**”) by Sunrise Technology Investment Holding Pte. Ltd. (the “**Offeror**”) of all the issued ordinary shares in the capital of Sunningdale Tech Ltd. (the “**Shares**”), other than the Shares in which Mr Koh Boon Hwee has a direct and deemed interest, by way of a scheme of arrangement (the “**Scheme**”) in accordance with Section 210 of the Companies Act, Chapter 50 of Singapore and the Singapore Code on Take-overs and Mergers (the “**Code**”), announced on 9 November 2020 (“**Scheme Announcement**”), and the joint announcement released on 19 January 2021 in relation to the increase to the Scheme Consideration (as defined in the Scheme Announcement).

As stated at paragraph 14 of the Scheme Announcement, UOB is the joint financial adviser to the Offeror in connection with the Acquisition and the Scheme.

#### **2. DISCLOSURE OF DEALINGS**
