



## SIA Engineering Company and GE Aviation Incorporate GE Aviation, Overhaul Services – Singapore

**SINGAPORE, 31 January 2020** – Mainboard-listed SIA Engineering Company Limited ("SIAEC") and GE Aviation ("GE") have incorporated an engine overhaul joint venture, GE Aviation, Overhaul Services – Singapore. This follows SIAEC and GE's announcement on 6 February 2018 of the signing of a definitive joint venture agreement with the intent to set up an engine overhaul joint venture to provide engine maintenance, repair and overhaul (MRO) services for the GE90 and GE9X engines.

The details of the joint venture company are as follows:

Name of Joint Venture Company: GE Aviation, Overhaul Services – Singapore

Issued Share Capital: USD 10,000 comprising 100 ordinary shares

Consummation of the joint venture transaction remains subject to satisfaction of certain terms and conditions, and the share capital of the joint venture company will be fully paid up by SIAEC and GE Aviation in due course.

Shareholding: 51% held by GE Aviation, 49% held by SIAEC

This joint venture company will commence operations in a newly developed state-of-the-art facility which adopts the GE Aviation Performance System (GEAPS). This system combines advanced technologies and lean practices with digitisation and data analytics to enhance productivity.

With this addition, SIAEC will have a comprehensive portfolio of 26 joint ventures across 8 countries with leading OEMs and other strategic partners.

The incorporation of the above joint venture company is not expected to have a material impact on the earnings per share or the net tangible assets per share of SIAEC for the financial year ending 31 March 2020. None of the Directors of SIAEC has any interest, direct or indirect, in the incorporation of the joint venture company.
