**SUCCESSFUL CLOSE OF MONEYMAX'S SERIES 011, SERIES 012 AND SERIES 013 DIGITAL SECURITY TOKENS TO BE LISTED ON THE "ADDX" SECURITY TOKEN TRADING PLATFORM UNDER ITS S\$100,000,000 UNSECURED COMMERCIAL PAPER PROGRAMME (THE "PROGRAMME")**

The board of directors (the "**Board**") of MoneyMax Financial Services Ltd. (the "**Company**") refers to the Company's announcements dated 9 January 2023, 24 September 2024 and 28 February 2025 in relation to the Programme (the "**Announcements**"). Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as ascribed to them in the Announcements.

The Board is pleased to announce that the offering of the Series 011 Tokens, the Series 012 Tokens and the Series 013 Tokens have closed at 12.00 p.m. (Singapore time) on 13 March 2025 and the Company has successfully raised:

- (i) S\$43.80 million in gross proceeds from the issuance of the Series 011 Tokens;
- (ii) S\$22.16 million in gross proceeds from the issuance of the Series 012 Tokens; and
- (iii) S\$1.74 million in gross proceeds from the issuance of the Series 013 Tokens.

The Series 011 Tokens, the Series 012 Tokens and the Series 013 Tokens will be listed on the ADDX Exchange on 14 March 2025.

#### *Series 011 Tokens*

The subscribers of the Series 011 Tokens include: (i) Dato' Sri Dr. Lim Yong Guan, the Executive Chairman, Chief Executive Officer and a controlling shareholder of the Company ("**Dato' Sri Dr. Lim**"); (ii) Mdm. Lim Liang Eng, a controlling shareholder of the Company and a sister of Dato' Sri Dr. Lim; (iii) Mdm. Lim Liang Cheng, a sister of Dato' Sri Dr. Lim; (iv) Mdm. Tan Yang Hong, the Chief Operating Officer of the Company and the spouse of Dato' Sri Dr. Lim; (v) Mr. Lim Yeow Hua, an Independent Non-Executive Director of the Company ("**Mr. Lim**") and (vi) Mdm. Yeh Siew Ho, the spouse of Mr. Lim (collectively, the "**Series 011 Related Parties**"). The Series 011 Related Parties had collectively subscribed for S\$14.48 million, representing 33.06% of the Series 011 Tokens.

#### *Series 012 Tokens*

The subscribers of the Series 012 Tokens include: (i) Dato' Sri Dr. Lim; (ii) Mdm. Lim Liang Eng; (iii) Mr. Lim Yong Sheng, the Non-Executive Director and a controlling shareholder of the Company and (iv) Mdm. Tan Yang Hong (collectively, the "**Series 012 Related Parties**"). The Series 012 Related Parties had collectively subscribed for S\$15.46 million, representing 69.77% of the Series 012 Tokens.



### Series 013 Tokens

The subscribers of the Series 013 Tokens include Mdm. Tan Yang Hong, who had subscribed for S\$0.06 million, representing 3.45% of the Series 013 Tokens.

The Company will make further announcements as appropriate, if and when there are material developments in relation to the Programme and the issuance of the Series 011 Tokens, the Series 012 Tokens and the Series 013 Tokens by the Company which warrant disclosure.
