Mr Philip Rickard holds 33.33% of the issued and paid-up share capital of Cerenti. Accordingly, Mr Rickard is deemed to be interested in the shares held by Cerenti. For avoidance of doubt, no consideration was received by Cerenti or Mr Sudarno from the transfer of the 6,983,807 shares from Cerenti to Mr Rickard.
