# NOTICE OF FURTHER APPLICATION HEARING DATE

### 1. INTRODUCTION

CapitaLand Commercial Trust Management Limited (the "<u>CCT Manager</u>"), as manager of CapitaLand Commercial Trust ("<u>CCT</u>"), refers to:

- (a) the announcement dated 22 January 2020 (the "Joint Announcement") issued by the CCT Manager and CapitaLand Mall Trust Management Limited, as manager of CapitaLand Mall Trust ("<u>CMT</u>"), in relation to the proposed merger of CMT and CCT through the acquisition by CMT of all the issued and paid-up CCT Units by way of a trust scheme of arrangement, to be effected in accordance with the Singapore Code on Take-overs and Mergers;
- (b) the announcement dated 10 March 2020 issued by the CCT Manager informing CCT Unitholders of the date of the first court hearing (the "<u>First Court Hearing Date</u> <u>Announcement</u>"); and
- (c) the announcement dated 12 March 2020 issued by the CCT Manager informing CCT Unitholders that the date of the first court hearing was rescheduled to 17 March 2020 (the "Change In First Court Hearing Date Announcement").

Unless otherwise defined, all capitalised terms used and not defined herein shall have the same meanings given to them in the Joint Announcement.

### 2. FURTHER APPLICATION HEARING DATE

Further to the First Court Hearing Date Announcement and the Change in First Court Hearing Date Announcement, the CCT Manager wishes to update CCT Unitholders that a further application in HC/OS 292/2020 (the "Further Application") has been filed with the Court for leave to, *inter alia*, convene, hold and conduct the Trust Scheme Meeting by electronic means during the period of time when the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 ("COVID-19 Alternative Meetings Order") is in effect and applies to relevant unit trusts (as defined in the COVID-19 Alternative Meetings Order). The CCT Manager wishes to inform CCT

Unitholders that the Court has directed that the Further Application be fixed for hearing at 4.00 p.m. on 12 August 2020.
