**ISSUE OF S\$150,000,000 3.25 PER CENT. GREEN NOTES DUE 2033 BY OUE TREASURY PTE. LTD. PURSUANT TO ITS S\$3,000,000,000 MULTICURRENCY DEBT ISSUANCE PROGRAMME, UNCONDITIONALLY AND IRREVOCABLY GUARANTEED BY OUE LIMITED**

The Board of Directors of OUE Limited (the “**Company**”) refers to the announcement made on 11 May 2026 (the “**Announcement**”) in relation to the proposed issue of S\$150,000,000 3.25 per cent. green notes due 2033 (the “**Series 005 Notes**”) by its wholly-owned subsidiary OUE Treasury Pte. Ltd. (the “**Issuer**”) pursuant to the S\$3,000,000,000 Multicurrency Debt Issuance Programme established by the Issuer on 30 November 2016 and unconditionally and irrevocably guaranteed by the Company (the “**Programme**”). Oversea-Chinese Banking Corporation Limited was the sole global coordinator, and DBS Bank Ltd., The Hongkong and Shanghai Banking Corporation Limited, Singapore Branch and Oversea-Chinese Banking Corporation Limited were the joint lead managers and bookrunners and the joint green finance structuring banks, for the issue of the Series 005 Notes.

Capitalised terms used but not defined herein shall, unless the context otherwise requires, have the meanings set out in the Announcement.

The Company wishes to announce that the Issuer has today issued the Series 005 Notes.

Approval in-principle has been received from the Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) for the listing and quotation of the Series 005 Notes on the SGX-ST. The Series 005 Notes are expected to be listed on the SGX-ST on or about 19 May 2026.

The SGX-ST assumes no responsibility for the correctness of any of the statements made, opinions expressed or reports contained herein. Approval in-principle from, admission to the Official List of, and the listing and quotation of the Series 005 Notes on, the SGX-ST are not to be taken as an indication of the merits of the Issuer, the Company, their respective subsidiaries (if any), their respective associated companies (if any), the Programme and/or the Series 005 Notes.
