**PROPOSED SALE OF 12 PENJURU LANE – FURTHER EXTENSION OF CALL OPTION
EXERCISE PERIOD**

1. The board of directors (the “**Board**” or “**Directors**”) of AEI Corporation Ltd. For the avoidance of doubt, Completion remains to take place no later than 19 March 2021.
