Immediately before the Transaction, Yao Hsiao Tung was deemed interested in 9,892,382 ordinary shares in the capital of Hi-P International Limited ("Shares") as Yao Hsiao Tung: (a) held 3,000,000 Shares under Raffles Nominees (Pte) Ltd; and (b) held options which allowed him to subscribe for an aggregate of 6,892,382 Shares.
