Pursuant to the Proposed Restructuring and as of 26 December 2017, Ocean Wonder International Limited ("OWIL") holds 5,523,070,991 ordinary shares in the capital of Oceanus Group Limited ("OGL").

AIF Capital Asia III, L.P. ("AIF LP") is the sole shareholder of OWIL and accordingly holds more than 50% of the voting rights in OWIL. AIF Capital Asia III GP Limited ("AIF GP") is the general partner of AIF LP. AIF Capital Partners Holdings, L.P. ("AIF CPH LP") is the sole shareholder of AIF GP and accordingly holds more than 50% of the voting rights in AIF GP.

AIF Capital Partners, Ltd. ("AIF Ltd") is the general partner of AIF CPH LP. Stephen Lee holds not less than 20% of the voting rights in AIF Ltd. Accordingly, Stephen Lee is deemed to have an interest as a substantial shareholder in the shares.
