However, pursuant to section 136 of the Securities and Futures Act, Temasek is filing this notification to report only the change in deemed interest from 83.70% to 83.69% which arises from a change in the total number of issued voting shares from 2,500,526,130 voting shares to 2,500,640,230 voting shares.

SIA is an independently managed Temasek portfolio company. Temasek is not involved in their business or operating decisions, including those regarding its position in the voting shares of the Listed Issuer.


