Thomas entered into a sale and purchase agreement ("SPA") on 25 March 2024 with certain shareholders ("Vendors") for the sale and acquisition of up to 43,337,408 ordinary shares ("Shares") of the Company ("Sale Shares") by Thomas from the Vendors . Accordingly, Thomas had a deemed interest in the 43,337,408 Sale Shares held by the Vendors which are to be transferred to Thomas in accordance with the terms of the SPA pursuant to Section 4(7) of the SFA.

Following the earlier transfer of 11,591,218 sale Shares from one of the vendors to Thomas on 7 April 2024 and 23,617,445 sale Shares from another vendor to Thomas on 15 May 2024, Thomas also received the transfer of the remaining 8,128,745 sale Shares from another vendor on 21 June 2024, pursuant to the terms of the SPA. These transfers complete all obligations under the SPA dated 25 March 2024.
