1. Issuance of the Tranche 3 Notes

The Board of the Company wishes to announce that an aggregate amount of S\$2,000,000 of the Tranche 3 Notes (Certificate Nos. 401 to 440) has been duly issued to the Subscriber as at 22 September 2016 in accordance with the terms and conditions of the Notes Issue.

The Company will make further announcements on the utilisation of the net proceeds from the Notes Issue as and when the proceeds are materially disbursed.

2. Allotment and issue of Shares pursuant to the conversion of the Tranche 3 Notes

The Board wishes to announce that the Subscriber has, on 22 September 2016, exercised its rights to convert one (1) Note (Certificate No. 428) in respect of the Tranche 3 Notes. The converted Note, with an aggregate principal value of S\$50,000 will be converted into 55,555,555 Conversion Shares at the Floating Conversion Price of S\$0.0009 for each Conversion Share on 22 September 2016. An aggregate amount of S\$1,400,000 of the Tranche 3 Notes has been converted as of 22 September 2016.

The Floating Conversion Price of S\$0.0009 was determined by taking 90% of the of the average of the traded volume weighted average prices per share for any three (3) consecutive Trading Days as selected by the Subscriber during the 30 Trading Days immediately preceding the relevant Conversion Notices dated, 22 September 2016.
