UPDATE ON MEMBERS' VOLUNTARY LIQUIDATION OF A WHOLLY-OWNED SUBSIDIARY

The board of directors (the "Board" or the "Directors") of Resources Global Development Limited (the "Company", together with its subsidiaries, the "Group") refers to the Company's announcement dated 23 August 2024 in relation to the dissolution by way of members' voluntary liquidation ("MVL") of the Company's wholly-owned subsidiary, RG International Commodities Pte. Ltd. ("RGIC").

The Board wishes to inform that, as advised by Mr. Abuthahir Abdul Gafoor and Ms. Yessica Budiman, both care of AAG Corporate Advisory Pte Ltd, the joint and several Liquidators for the MVL, pursuant to Section 180(6) of the Insolvency, Restructuring and Dissolution Act 2018 (Act 40 of 2018), RGIC will be dissolved on or around 26 June 2025, three (3) months after the lodgement of the Final Return with the Accounting and Corporate Regulatory Authority ("ACRA").
