FPL therefore has a deemed interest in the Units in which each of FCAM and FPRTH has an interest, by virtue of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore ("SFA").

MM holds a 100% direct interest in each of Maxtop Management Corp. ("MMC"), Risen Mark Enterprise Ltd. ("RM") and Golden Capital (Singapore) Limited ("GC");

- MMC, RM and GC collectively holds a greater than 20% interest in Thai Beverage Public Company Limited ("ThaiBev");

The REIT Manager had, on 9 October 2020, launched a non-renounceable preferential offering of 324,639,666 new Units ("New Units") on the basis of 290 New Units for every 1,000 existing Units (fractions of a New Unit to be disregarded) held as at 5.00 p.m. on Tuesday, 6 October 2020 (the "Preferential Offering"). Under the Preferential Offering, 188,870,419 New Units were issued to FPRTH and FCAM. MM is therefore deemed interested in an aggregate of 687,790,767 Units.
