While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

There must be no netting-off of two or more notifiable transactions even if they occur within the same day.

- The change in Ms Chua Sock Koong ("Ms Chua")'s deemed interest is a consequence of the vesting of the performance shares granted to her in 2016 and 2017 (see details in paragraphs 2 and 3 below). The deemed interest of 2,112,347 shares immediately after the transaction in Table 1 comprises:
 - 28,137 ordinary shares held by Mr Lee Swee Kiat, spouse of Ms Chua; and
 - an aggregate of up to 2,084,210 ordinary shares in Singapore Telecommunications Limited ("Singtel") awarded to Ms Chua in 2017 and 2018 (see paragraphs 3 and 4 below) pursuant to the Singtel Performance Share Plan 2012 ("PSP 2012"), subject to certain performance conditions being met and other terms and conditions. Depending on the extent of the satisfaction of the relevant performance criteria, up to an aggregate of 2,816,878 shares may be released pursuant to the conditional awards granted.
- Performance shares granted to Ms Chua in 2016:
 - In respect of the 201,331 shares comprised in the Restricted Share Award ("RSA") granted to Ms Chua in 2016 under the PSP 2012, 135.8% or 273,408 of such shares have vested in accordance with the Rules of the PSP 2012. 50% or 136,704 of such shares have been released to Ms Chua on 1 June 2018, and 50% or 136,704 of such shares have been released to Ms Chua on 3 June 2019.
 - In respect of the 1,694,657 shares comprised in the Performance Share Award ("PSA") granted to Ms Chua in 2016 under the PSP 2012, none of the shares have vested.
- Performance shares granted to Ms Chua in 2017:
 - In respect of the 382,987 shares comprised in the RSA granted to Ms Chua in 2017 under the PSP 2012, 116.1% or 444,648 of such shares have vested/will vest in accordance with the Rules of the PSP 2012. 50% or 222,324 of such shares have been released to Ms Chua on 3 June 2019. 50% or 222,324 of such shares will be released to Ms Chua on or after 1 June 2020.
 - In respect of the PSA granted to Ms Chua in 2017, depending on the extent of satisfaction of the relevant performance criteria, up to an aggregate of 1,247,577 shares may be released.
- Performance shares granted to Ms Chua in 2018:
 - In respect of the 497,833 shares comprised in the Special Share Award granted to Ms Chua in 2018 under the PSP 2012, 100% or 497,833 of such shares have vested in accordance with the Rules of the PSP 2012.
 - In respect of the RSA granted to Ms Chua in 2018, depending on the extent of satisfaction of the relevant performance criteria, up to an aggregate of 396,550 shares may be released. In respect of the PSA granted to Ms
