PAYMENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN FIRST REAL ESTATE INVESTMENT TRUST

The Board of Directors of Bowsprit Capital Corporation Limited (the “**Company**”), the Manager of First Real Estate Investment Trust (“**First REIT**”) wishes to announce that 1,469,461 Units have been issued to the Company on 18 July 2014 at an issue price of S\$1.1839 per Unit. These Units were issued to the Company in payment of 77% of the Management Fee comprising the Base Fee and Performance Fee (as defined in the Trust Deed constituting First REIT, (“the **Trust Deed**”)) for the period from 1 April 2014 to 30 June 2014. The balance of the Management Fee (as defined in the Trust Deed) of S\$519,649.24 (excluding applicable goods and services tax) was paid in cash.

With the above-mentioned issue of Units, the Company holds an aggregate of 34,253,268 Units, representing 4.74% of the total number of Units in issue of 722,997,820.
